## Terms & Conditions

Unless inconsistent terms are specifically stated in a Sales Agreement or other documents sent by Creditor to Applicant, or signed by an authorized officer of Weaver Precast, Inc. and pertain to a particular purchase, all purchases made by applicant shall be subject to the following terms and conditions:

1. Creditor reserved complete discretion concerning all extensions of credit and shall have the right at any time to refuse credit to the Applicant.
2. Creditor shall bear no responsibility for any architectural plans, drafts or other services, which it may provide to the Applicant in the course of business. Applicant acknowledges and agrees that in providing such plans, drafts or services, Creditor acts merely as a facilitator and any claims for defects therein shall lie exclusively against the architect who sealed such plans or drafts or who provided such architectural services.
3. Applicant acknowledges and agrees that all purchases made by it shall be paid for in accordance with such payment terms as from time to time be established by Creditor. Until otherwise notified by Creditor, the following payment terms shall apply: (i) the Applicant's account shall be billed as of the date the foundation is delivered; (ii) the net amount of each invoice is due on day of delivery unless prior arrangements have been made, and (iii) any invoice not paid in full 30 days from the date on the invoice will be subject to a finance charge of one and a half percent (1 ½%) per month, but not in excess of the highest rate allowed by law.
4. The parties hereto agree that this Agreement shall be deemed to be executed, entered into and accepted in Lancaster County, Pennsylvania. The rights of the parties and provisions of this Agreement shall be interpreted, construed, and governed in accordance with the laws of the Commonwealth of Pennsylvania. By execution of this Agreement, all parties to this Agreement consent to the exercise over themselves of the general personal jurisdiction of the courts of record of Lancaster County. Both parties hereto agree that all causes of action and claims arising out of this Agreement shall be litigated only in courts of record in Lancaster County, Pennsylvania, even though it may be otherwise possible to obtain jurisdiction over either or both parties elsewhere.
5. In the event that the purchaser fails to pay Weaver Precast, Inc. for materials or services provided pursuant to this Contract, the purchaser shall pay all costs of collection including, but not limited to, court costs, private process service, and actual attorney's fees.

This Application and Agreement shall be governed by and construed in accordance with the laws of The Commonwealth of Pennsylvania.

**Any change, alteration, or deletion of any term or condition in this form without approval by Creditor will cause the application to be immediately rejected.**

In consideration for any extension of credit, purchaser agrees to the terms and conditions set forth on each invoice and contract.
